MINUTES

MEETING OF THE SUB-COMMITTEE OF NATIONAL COUNCIL FOR VOCATIONAL TRAINING (NCVT) DEALING WITH AFFILIATION HELD ON 31st July, 2014 AT 11.00 A.M. IN MAIN COMMITTEE ROOM OF MINISTRY OF LABOUR & EMPLOYMENT, SHRAM SHAKTI BHAWAN, NEW DELHI.

Meeting of the Sub-Committee of NCVT dealing with affiliation was held on 31st July, 2014 at 11.00 A.M. under the chairmanship of **Shri Alok Kumar, Director General/Joint Secretary**. The list of members present in the meeting is at Annex 'A'.

At the outset, Director General, extended warm welcome to the members and advised Director of Training to proceed the meeting.

The Sub-Committee noted the phenomenal increase in numbers of units of trade Electrician across the country and especially in the State of Rajasthan. DG/JS tried to find out the reasons of demand of only two trades (Electrician & Fitter). Major reasons come out are as:

- Investment for the trade Electrician is lowest and General machinery is common for four units and may be extended to six units by including third shifts.
- There are some schemes like Rajiv Gandhi Electrification etc. mandated for Electrification of rural parts of the country.
- There are ample opportunities in the Government sectors like Rajasthan Electricity board (Now limited companies) as well as scope of self-employment with low investment.

In this regard, DG/JS desired to convene a meeting with Principal Secretary of Rajasthan to discuss the issue and find out feasible solution to rationalize the number of the units for particular trade in the district as well as State following the recommendation of Working Group which entails a review of capacities of various trades in each district.

Item No. 1: Confirmation of minutes of the meeting held on 02.07.2014.

DG/JS reviewed the minutes of the last meeting held on 2nd July, 2014 and advised to ensure uploading of show cause notices & details of de-affiliation on re-structured web site of DGE&T. Sub-Committee confirmed the minutes.



Item No. 2: Proposal for consideration of used machines in working condition.

Issue of provision of inclusion of used machines was discussed at length with all its pros & cons. Members expressed apprehensions of misuse of the proposed provision. Shri A.K. Jain Principal Advisor, QCI highlighted uphill task of accreditation in terms of judgement of working of old machines as new machine with improper maintenance may have worn out and vice versa.

The Sub-Committee did not accept the proposal and decided to continue existing system.

Item no.3: Removal of additional norms framed by State Government(s)

Regarding additional norm framed by State of Rajasthan to deposit Performance Bank Guarantee @ Rs. 50,000/- per unit for affiliated trades from NCVT as a mandatory, the Sub-committee deliberated the issue and decided to advise states not to frame any additional norms without prior permission of NCVT/DGE&T for trades/units affiliated with NCVT and State of Rajasthan be advised to discontinue this exercise.

Item No 4. : Relaxation for maximum one year to purchase CNC machine for shifting of institute from one location to another, in respect of Acharya Private ITI, Bangalore.

The matter of relaxation of one year to purchase CNC machine in respect of Acharya Pvt. ITI, Bangalore-29 being shifted to new location was considered by the Sub-Committee and it was highlighted that it would be un-reasonable to do this provision for a particular trade for a Machine and may invite unexpected complication and imbalances.

Sub-Committee decided not to grant relaxation of any time period and advise institute to procure CNC machine at the earliest to get trade Turner accredited by QCI for further grant of affiliation.

Item No 5. : Consideration of recommendations in respect of inspection reports/Clarification received from States/UTs. and QCI.

Affiliation inspection reports/Clarification received from various States/UTs and QCI were put up for consideration of Sub-Committee of NCVT dealing with affiliation.

Sub-Committee discussed total of 432 of accreditation of ITIs, CoEs & IToTs and accorded approval to the cases conforming to NCVT norms.

Additional Items:

a. Representative of State Bihar, Sh. Sanjay Kumar, Assistant Director brought to the notice that third shift is not being implemented in the State of Bihar while it is working in other States and a mass, working in day time in industry is being benefited. In this context, Chairman advised to correspond with State of Bihar & other , if any to allow implementation of third shift similar to other States.

b. Two cases (App002051 Agrasen Private ITI, Mahendergarh, Dist. Korea & App002279 Shri Agrasen Private ITI, Bhilai, Dist. Durg) pertaining to Chhattisgarh kept in abeyance, State has to furnish clarification.

c. During the meeting, it was noticed that 3 cases (1 each for Chandigarh, Maharashtra & Gujarat) could not be included in the list of proposals in spite of their recommendation on respective files as approved. DG/JS advised to include these 3 cases. Sub-Committee approved these cases.

d. Sh A.K.Jain, QCI apprised that nearly 600 affiliation proposals are in pipeline for accreditation and likely to submitted in phased manner. In this context, next date of meeting has been scheduled on **25.08.2014**.

The meeting ended with a vote of thanks to the chair.
